Salon Suites offers hair, nails, massage

Sun Valley Salon Suites to soon open

Myron and Claudette Jacobs hope to soon open Sun Valley Salon Suites in Indian Trail.

The new facility will be at 6601 Old Monroe Road.

When open, it will offer a variety of salon style suites for interested hair and nail stylists, massage therapists and others.

"We're targeting Oct. 15," Myron Jacobs said in reference to when construction on the new facility will be complete.

Not long after that they hope to have all the necessary paperwork finished and be able to open to the public. When open, the facility will consist of 24 individual private suites. Those interested will be able to rent the suites to operate their own salon out of the facility, he said.

"You're owning your own business but in a contained space," he said in reference to the overall idea of Sun Valley Salon Suites.

They already have some people interested in owning some of the suites and are working to bring in more. Sun Valley Salon Suites will be the first of its type that he and his wife have operated though his wife, Claudette Jacobs, currently operates Echo Nail Spa in Monroe, he said.

"We live here (Union County) we want to do business here and there's nothing like this in Union

County, at least not of this size," he said.

There are similar facilities to it around the Charlotte area but they want to help keep stylists in Union County, which is one of the reasons they're choosing to build Sun Valley Salon Suites in Indian Trail. They also want to help keep the stylists' customers in Union County, which would help with the local economy. The new facility will also allow people to not have to drive as far for the beauty, nail and other services offered at its various suites, he said.

"We hope for it to be full, to have all 24 suites to be leased out," he said.

Eventually they hope to expand further and to possibly build more similar facilities throughout the county, he said.

"We're excited about this opportunity and look forward to start servicing the public in October," he said.
